CDE funded families only: Payment is due each Thursday and considered late on Wednesday at 5:45 p.m. A NOA will be sent when payment is received late. There are no reductions for absences, illnesses, holidays, or vacations.

### Section V - Hours

Kinder World is open 7:15 a.m. to 5:45 p.m.; optional late or early care is available for a fee. A late charge of \$1/minute is assessed when a child attends outside of their contracted hours. Two weeks written notice of intent to withdraw from Kinder World is required; otherwise you are obligated to pay tuition for an additional month. The undersigned understands that Licensing requires that Kinder World have on file notification that the Department of Social Services may interview your child at Kinder World if necessary.

### Section VI - Etc.

Kinder World is not responsible for personal property. Kinder World reserves the right to refuse to allow personal property that is valued at \$30 or more, and not medically necessary, to be kept on the premises. Kinder World management reserves the right to suspend or dismiss a student or family from the program at any time for behavior that is verbally abusive or endangers the safety of the children or staff at Kinder World.
